CLASSES OF MEMBERSHIP

Affiliate Member

- Those individuals who provide a support service to the clinical research industry
- Those who have an interest in clinical research
- Those new to clinical research
- Students in full or part-time undergraduate study
- Retired members who no longer work within the clinical research industry
- Those with no clinical research academic qualification
- Those studying for a clinical research academic qualification (see Qualifications)

Registered Member (RICR)

- Those who hold a BSc in Life Sciences (or equivalent); or a clinical research academic qualification (e.g. MSc, PgDiploma etc); or nursing qualification or have passed the ICR exam or hold a cognate degree
- Must have at least one year's experience in clinical research
- Members need to commit to CPD
- Must abide by ICR's Professional Code of Conduct (available on website)

Professional Member (MICR)

- As for Registered but have an additional 4 years' experience in clinical research
- Must provide evidence of achieving the required number of CPD points per annum on request

Fellow (FICR) By application only; must be considered and granted by 'The Board'.

As for Professional Members and in addition:

- Must be Professional member for at least 3 years
- Must have at least 10 years' experience in clinical research
- Must provide evidence of a minimum of 2 years' of CPD Once Fellowship granted must continue to provide evidence of achieving the required number of CPD points per annum every year.

Honorary Fellow (HonFICR)

By nomination only.

- Those who have made a significant contribution to the Institute
- Those who have made a significant contribution to the clinical research profession

Voting Rights

Affiliate Members do not have voting rights.

Registered Members, Professional Members, Fellows and Honorary Fellows have voting rights.

Professional Members and Fellows may apply to become a Director of ICR.

Qualifications

Clinical research academic qualifications include (but not limited to):

- Certificate in Clinical Research
- Post-graduate Certificate in Clinical Trial Administration
- Post-graduate Diploma in Clinical Research
- Masters in Clinical Research

If in doubt please ask ICR if your qualifications are appropriate.

Discounts

- A discount of 25% will apply to all ICR members who work for an Academic Institution, the Health Service or are students.
- Discount available on direct debit payments
